PLEASE RETAIN FOR YOUR RECORDS

By applying for membership to the Woodchester Mansion Trust Limited you agree to support the aims and objectives of WMT (principally the preservation and restoration of the Mansion as far as practicable to its original condition at the time of its abandonment in 1873, and the provision of education and training facilities to stonemasons, architects and others concerned with Cotswold stone building and other traditional skills).

You also undertake to observe and be bound by (i) WMT's Memorandum and Articles of Association which include an obligation to contribute a one off payment of not more than £1 (one pound) to WMT's assets, but only in the event of WMT being wound up and by (ii) the terms and conditions of membership set out below.

Terms and conditions of membership:

1. Membership of WMT shall entitle members to the following rights and benefits:
 - a membership card entitling the member to unlimited free visits to the Mansion;
 - occasional newsletters reporting on developments at the Mansion;
 - a reduction of £10 from the next year's annual membership fee (Annual Fee - see below) for those who volunteer on average once a month over a complete membership year; and
 - the right to attend and vote at general meetings of WMT, including the Annual General Meeting at which WMT's annual accounts are presented.
2. The membership year shall be from 1st January to 31st December. Subject to para. 3 below, a new **Single** member shall pay an Annual Fee of £35, and £35 (or such other Annual Fee as shall be notified from time to time to members by WMT) for subsequent membership years, such sum to be paid **online (Direct Debit/direct payment) or by card or cheque (NB: please delete whichever is not applicable to you) to: Woodchester Mansion Trust Limited, Lloyds Bank plc, Sort code: 30-98-29, Account No: 02072040, marked "Fee/[your name]"**
3. A member applying for membership may apply for **Plus 1** membership of WMT, in which event:
 - the member will be entitled to visit the Mansion at any time accompanied by one other visitor free of charge; and
 - the Fee for the period to 31st December would be £40, and £40 (or such other Annual Fee as shall be notified to members as above) for subsequent membership years, such sum to be paid as described in para. 2 above.
4. Save as provided above WMT's intention is that the Annual Fee should be fixed for a period of three years after any increase. However, WMT reserves the right to increase the Annual Fees as often as necessary and by such amount as is considered appropriate to reflect the rights and benefits provided to members, inflation and such other issues as WMT considers relevant, including the charges made by other institutions. WMT also reserves the right to forego the Fee for those who in the directors' opinion have made exceptional contributions to the charity over an extended period.
5. Members who do not pay the Annual Fee within thirty days of receiving a written or email reminder that their Annual Fee remains outstanding will be removed from the Register of Members, whereupon they will cease to be entitled to the above-mentioned rights and benefits.
